Action	The person/people with the original vision for some form of collaboration.	Champions establish a strong business and/or impact case for others to consider participation in the collaboration opportunity. First (bilateral) engagement occurs.	Collaborators raise awareness of the issue to be solved and grow their understanding through evidence review, engagement and initial dialogue.	Process of joint discovery and debate to align members towards the same goals and actions.	Organisations support each other but in pursuit of their individual goals, through or independently of the core organisation.	Finding ways to coordinate independent efforts with other actors and joint initiatives.	A community of actors with a shared interest to work jointly to address major issues in their communities / territories / sectors / value chains find ways to take action together.
